387. FLIGHT AND DUTY TIME LIMITATIONS (RULES PART 136.981).

A certificate holder who fails to comply with the requirements of Rule Part 136.981 is guilty of an offence.

Penalty:

Division 16. - Subpart Q - Manuals, Logs and Records.

388. OPERATING INFORMATION (RULES PART 136.1003).

A certificate holder who fails to comply with the requirements of Rule Part 136.1003 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

389. DOCUMENTS TO BE CARRIED (RULES PART 136.1005).

A certificate holder who fails to comply with the requirements of Rule Part 136.1005 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

390. DAILY FLIGHT RECORD (RULES PART 136.1007).

A certificate holder who fails to comply with the requirements of Rule Part 136.1007 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

391. RETENTION PERIOD (RULES PART 136.1009).

A certificate holder who fails to comply with the requirements of Rule Part 136.1009 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

PART VI. - CIVIL AVIATION RULE PART 137 - AGRICULTURE AIRCRAFT OPERATIONS.

Division 1. - Subpart A - General.

392. REQUIREMENT FOR RATINGS (RULES PART 137.3).

A pilot who fails to comply with the requirements of Rule Part 137.3 is guilty of an offence.

Penalty:

For an individual, a fine of K5,000.00.

393. REQUIREMENT FOR CERTIFICATE (RULES PART 137.5).

A person who fails to comply with the requirements of Rule Part 137.3 is guilty of an offence.

Penalty:

For an individual, a fine of K5,000.00, and for a company, a fine of

K10,000.00.

394. ACCIDENTS AND INCIDENTS (RULES PART 137.7).

A person who fails to comply with the requirements of Rule Part 137.7 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00, and for a company, a fine of

K3,000.00.

Division 2. - Subpart B - Flight Rules.

395. DIRECTION OF TURNS AT AERODROMES (RULES PART 137.53).

A pilot who fails to comply with the requirements of Rule Part 137.53 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00.

396. OPERATIONS OVER CONGESTED AREAS (RULES PART 137.55).

A pilot who fails to comply with the requirements of Rule Part 137.55 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00.

397. OPERATIONS OVER NON-CONGESTED AREAS (RULES PART 137.57).

A pilot who fails to comply with the requirements of Rule Part 137.57 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00.

398. FUEL RESERVES (RULES PART 137.59).

A pilot who fails to comply with the requirements of Rule Part 137.59 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00.

Division 3. - Subpart C - Special Flight Rules.

399. MAXIMUM TAKE-OFF WEIGHT (RULES PART 137.103).

A pilot who fails to comply with the requirements of Rule Part 137.103 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00.

400. TAKE-OFF DISTANCE AND FLIGHT PATH - NO THIRD-PARTY RISK (RULES PART 137.105).

A pilot who fails to comply with the requirements of Rule Part 137.105 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00.

401. TAKE-OFF DISTANCE - THIRD-PARTY RISK (RULES PART 137.107).

A pilot who fails to comply with the requirements of Rule Part 137.107 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00.

402. TAKE-OFF FLIGHT PATH - THIRD-PARTY RISK (RULES PART 137.109).

A pilot who fails to comply with the requirements of Rule Part 137.109 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00.

Division 4. - Subpart D - Commercial Operations - General.

403. DURATION OF CERTIFICATE (RULES PART 137.155).

An agriculture aircraft operator certificate holder who fails to comply with the requirements of Rule Part 137.155 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

404. RENEWAL OF CERTIFICATE (RULES PART 137.157).

An agriculture aircraft operator certificate holder who fails to comply with the requirements of Rule Part 137.157 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

Division 5. - Subpart E - Commercial Operations - Operating Requirements.

405. RECORDS (RULES PART 137.201).

An agriculture aircraft operator certificate holder who fails to comply with the requirements of Rule Part 137.201 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

406. REMOTE BASED OPERATIONS (RULES PART 137.203).

An agriculture aircraft operator certificate holder who fails to comply with the requirements of Rule Part 137.203 is guilty of an offence.

Penalty:

407. OPERATIONS OVER CONGESTED AREAS (RULES PART 137.205).

An agriculture aircraft operator certificate holder, or a pilot who fails to comply with the requirements of Rule Part 137.205 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00, and for a company, a fine of

K3,000.00.

408. PERSONNEL REQUIREMENTS (RULES PART 137.207).

An agriculture aircraft operator certificate holder who fails to comply with the requirements of Rule Part 137.207 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

409. CHANGES TO OPERATIONS (RULES PART 137.209).

An agriculture aircraft operator certificate holder who fails to comply with the requirements of Rule Part 137.209 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

Division 6. - Subpart F - Instruments and Equipment.

410. GENERAL (RULES PART 137.253).

A person who commences an agricultural aircraft operation without complying with the requirements of Rule Part 137.253 is guilty of an offence.

Penalty:

For an individual, a fine of K5,000.00, and for a company, a fine of

K10,000.00.

411. SEATING AND RESTRAINTS (RULES PART 137.255).

An agriculture aircraft operator certificate holder who fails to comply with the requirements of Rule Part 137.255 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

412. ADDITIONAL INSTRUMENTS (RULES PART 137.257).

An agriculture aircraft operator certificate holder who fails to comply with the requirements of Rule Part 137.257 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

413. ADDITIONAL EQUIPMENT (RULES PART 137.259).

An agriculture aircraft operator certificate holder who fails to comply with the requirements of Rule Part 137.259 is guilty of an offence.

Penalty:

PART VII. - MISCELLANEOUS.

414. APPLICATION OF OTHER ACTS.

For the purposes of prosecution under this Regulation, the following provisions of the *Criminal Code Act* 1974 shall apply:

- (a) Section 7 of that Act relating to offences committed in prosecution of common purposes; and
- (b) Section 8 of that Act relating to offences committed in prosecution of common purposes; and
- (c) Section 9 of that Act relating to mode of execution immaterial; and
- (d) the provisions of Subsection 10(1) only, of that Act relating to accessories after the fact.

415. PRESERVATION OF RIGHTS AND LIABILITIES UNDER OTHER LAWS, ETC.

Except where the contrary intention appear, nothing in this Regulation takes away from any persons any defence, right or liability, whether civil or criminal that -

- (a) is or has been available, acquired or incurred; or
- (b) will or may be available, acquired or incurred, to or by him under any other law, but nothing in this section shall be deemed to show a contrary intention within the meaning of the *Interpretation Act* (Chapter 2) or to affect Section 16 of the Criminal Code, or any other similar law.

416. STANDARD OF PROOF.

The standard of proof to be applied in proceedings under this regulation shall be that applied in civil proceedings, namely, proof on the balance of probabilities.

417. INFRINGEMENT FINES.

The fines prescribed under this Regulation, shall be payable to the Authority.

418. ON-THE-SPOT INFRINGEMENT FINES.

- (1) Where it appears to a member of the Authority or a prescribed officer that a person has committed a prescribed offence against this Regulation, the member of the Authority or prescribed officer may serve on the person a notice in the prescribed form to the effect that if he does not desire to have the matter determined by a court he may pay to an officer specified in the notice, within the time specified in the notice, the amount of the penalty prescribed for the offence if dealt with under this section.
 - (2) A notice under Subsection (1) may be served -
 - (a) personally; or
 - (b) by post; or
 - (c) by electronic means; or
 - (d) by leaving it on or in the premises of the person.

- (3) It is sufficient for the notice to be addressed in a letter format, containing the charge and the facts on which an offence has been committed and the appropriate fine.
- (4) A person alleged to have committed an offence to which Subsection (1) applies has the right to decline to be dealt with under this section.
- (5) For the purposes of Subsection (3), a person who fails to pay, within the time specified in the notice or such further time as is allowed in any particular case, the penalty to which a notice under Subsection (1) relates shall be deemed to have declined to be dealt with under this section.
- (6) Where the amount of the prescribed penalty for an alleged offence is paid in accordance with this section, no person is liable to any further proceedings for the offence.
- (7) Payment, in accordance with this section, of a penalty in respect of an alleged offence -
 - (a) shall not be regarded as an admission of liability for the purposes of this Regulation; and
- (b) does not affect or prejudice, any criminal proceedings, other than proceedings for the alleged offence or any civil claim, action or proceeding arising out of the same occurrence.
- (8) A penalty prescribed for the purposes of this section for a prescribed offence shall not exceed the maximum amount of penalty that could be imposed for the offence by a court.
- (9) Subject to Subsection (5) and (6), this section is supplementary to, and not in derogation of, any other provision of the Act, this Regulation or any other law in relation to proceedings that may be taken in respect of prescribed offences.
- (10) Notwithstanding the Constitutional provisions relating to the imposition of a fine without a Court hearing, it is in the National interest for the benefit of public safety for an 'On The Spot' infringement fine to be imposed as a form of penalty according to the offender's desire.

419. POWERS OF ARREST.

- (1) Notwithstanding any other law but subject to the provisions of the *Arrest Act* (Chapter 339), this section applies to and in relation to an arrest for an offence made by or under this Regulation.
- (2) A policeman, an authorised office or agent of the Authority may, without warrant, arrest a person whom they believe on reasonable grounds:
 - (a) is committing; or
- (b) has committed an offence, under this Regulation.

(3) For the purposes of this section a "policeman" means a member of the Police Force and includes Reserve Constabulary.
