Civil Aviation (Certified Airways Services and Airspace) (Offences) Regulation 2022.

Being a Regulation to provide for offences and penalties pursuant to Section 322 of the *Civil Aviation Act* 2000 in relation to Civil Aviation Rule Part 71, 77, 171, 172, 173, 174, 175 and 176, and for related purposes,

MADE by the Head of State, acting with, and in accordance with, the advice of the National Executive Council under the *Civil Aviation Act* 2000.

PART I. - CIVIL AVIATION RULE PART 71 - DESIGNATION OF AIRSPACE.

Division 1. - Subpart A - General.

1. APPLICATION FOR DESIGNATION AND CLASSIFICATION OF AIRSPACE (RULE PART 71.7).

A person who applies for an airspace designation or classification without complying with the requirements of Rule Part 71.1 is guilty of an offence.

Penalty:

For an individual, a fine of K5,000.00, and for a company, a fine of K10,000.00.

Division 2. - Subpart D - Special Use Airspace.

2. RESTRICTED AREAS (RULE PART 71.153).

A person who operates an aircraft in a restricted area without authority as required under Rule Part 71.153 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00, and for a company, a fine of K3,000.00.

3. DANGER AREAS (RULE PART 71.155).

A person who operates an aircraft in a danger area as described under Rule Part 71.155 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00, and for a company, a fine of K3,000.00.

4. PROHIBITED AREAS (RULE PART 71.157).

A person who operates an aircraft in a prohibited area as described under Rule Part 71.157 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00, and for a company, a fine of

K3,000.00.

5. LOW FLYING ZONES (RULE PART 71.159).

A person who operates an aircraft in a low flying zone without complying with the requirements of Rule Part 71.159 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00, and for a company, a fine of

K3,000.00.

6. TEMPORARY AIRSPACE (RULE PART 71.163).

A person who operates an aircraft in a temporary airspace as described in Rule Part 71.163 is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00, and for a company, a fine of

K3,000.00.

Division 3. - Subpart E - Transponder Mandatory Airspace.

7. TRANSPONDER MANDATORY AIRSPACE WITHIN CONTROLLED AIRSPACE (RULE PART 71.201).

A person who operates an aircraft in an airspace as described in Rule Part 71.201 without complying with this Rule is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00, and for a company, a fine of

K3,000.00.

8. TRANSPONDER MANDATORY AIRSPACE WITHIN SPECIAL USE AIRSPACE (RULE PART 71.203).

A person who operates an aircraft in an airspace as described in Rule Part 71.203 without complying with this Rule is guilty of an offence.

Penalty:

For an individual, a fine of K2,000.00, and for a company, a fine of

K3,000.00.

Penalty:

A person who proposed to use pyrotechnics without complying with the requirements of Rule Part 77.11 is guilty of an offence.

Penalty:

13. NOTICE REQUIREMENTS (RULE PART 77.13).

A person who fails to comply with the requirements of Rule Part 77.13 is guilty of an offence.

Penalty:

For an individual, a fine of K5,000.00, and for a company, a fine of

14. ADDITIONAL NOTICE REQUIREMENTS (RULE PART 77.15).

A person who fails to comply with the requirements of Rule Part 77.15 is guilty of an offence.

Penalty:

For an individual, a fine of K5,000.00, and for a company, a fine of

K10,000.00.

15. COMPLIANCE (RULE PART 77.23).

A person who fails to comply with the requirements of Rule Part 77.23 is guilty of an offence.

Penalty:

For an individual, a fine of K5,000.00, and for a company, a fine of K10,000.00.

A holder of an aeronautical information service certificate who fails to comply with the requirements of Rule Part 176.13 is guilty of an offence.

Penalty:

Division 2. - Subpart B - Certification Requirement.

222. PERSONNEL REQUIREMENTS (RULE PART 176.51).

A certificate holder who fails to comply with the requirements of Rule Part 176.51 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

223. FACILITY REQUIREMENTS (RULE PART 176.53).

A certificate holder who fails to comply with the requirements of Rule Part 176.53 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

224. SECURITY PROGRAMME (RULE PART 176.55).

A certificate holder who fails to comply with the requirements of Rule Part 176.55 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

225. SCOPE OF SEARCH AND RESCUE SERVICE (RULE PART 176.57).

A certificate holder who fails to comply with the requirements of Rule Part 176.57 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

226. DOCUMENTATION (RULE PART 176.59).

A certificate holder who fails to comply with the requirements of Rule Part 176.59 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

227. PREPARATORY OF INFORMATION (RULE PART 176.61).

A certificate holder who fails to comply with the requirements of Rule Part 176.61 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

228. PLANS OF OPERATION (RULE PART 176.63).

A certificate holder who fails to comply with the requirements of Rule Part 176.63 is guilty of an offence.

Penalty:

SEARCH AND RESCUE SIGNALS (RULE PART 176.65). 229.

A certificate holder who fails to comply with the requirements of Rule Part 176.65 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

RECORDS (RULE PART 176.67). 230.

A certificate holder who fails to comply with the requirements of Rule Part 176.67 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

TRAINING AND EXERCISES (RULE PART 176.69). 231.

A certificate holder who fails to comply with the requirements of Rule Part 176.69 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

SAFETY MANAGEMENT SYSTEM (RULE PART 176.71). 232.

A certificate holder who fails to comply with the requirements of Rule Part 176.71 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

QUALITY MANAGEMENT SYSTEM (RULE PART 176.73). 233.

A certificate holder who fails to comply with the requirements of Rule Part 176.73 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

ORGANISATION EXPOSITION (RULE PART 176.75). 234.

A certificate holder who fails to comply with the requirements of Rule Part 176.75 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

Division 3. - Subpart C - Operating Requirement.

CONTINUED COMPLIANCE (RULE PART 176.101). 235.

A certificate holder who fails to comply with the requirements of Rule Part 176.101 is guilty of an offence.

Penalty:

236. SEARCH AND RESCUE SERVICES (RULE PART 176.105).

A certificate holder who fails to comply with the requirements of Rule Part 176.105 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

237. CHANGES TO CERTIFICATE HOLDER'S ORGANISATION (RULE PART 176.107).

A certificate holder who fails to comply with the requirements of Rule Part 176.107 is guilty of an offence.

Penalty:

For a company, a fine of K3,000.00.

PART IX. - MISCELLANEOUS.

238. APPLICATION OF OTHER ACTS.

For the purposes of prosecution under this Regulation, the following provisions of the *Criminal Code Act* 1974 shall apply:

- (a) Section 7 of that Act relating to offences committed in prosecution of common purposes; and
- (b) Section 8 of that Act relating to offences committed in prosecution of common purposes; and
- (c) Section 9 of that Act relating to mode of execution immaterial: and
- (d) the provisions of Subsection 10(1) only, of that Act relating to accessories after the fact.

239. PRESERVATION OF RIGHTS AND LIABILITIES UNDER OTHER LAWS, ETC.

Except where the contrary intention appear, nothing in this Regulation takes away from any persons any defence, right or liability, whether civil or criminal that -

- (a) is or has been available, acquired or incurred; or
- (b) will or may be available, acquired or incurred, to or by him under any other law, but nothing in this section shall be deemed to show a contrary intention within the meaning of the *Interpretation Act* (Chapter 2) or to affect Section 16 of the Criminal Code, or any other similar law.

240. STANDARD OF PROOF.

The standard of proof to be applied in proceedings under this regulation shall be that applied in civil proceedings, namely, proof on the balance of probabilities.

241. INFRINGEMENT FINES.

The fines prescribed under this Regulation, shall be payable to the Authority.

242. ON-THE-SPOT INFRINGEMENT FINES.

- (1) Where it appears to a member of the Authority or a prescribed officer that a person has committed a prescribed offence against this Regulation, the member of the Authority or prescribed officer may serve on the person a notice in the prescribed form to the effect that if he does not desire to have the matter determined by a court he may pay to an officer specified in the notice, within the time specified in the notice, the amount of the penalty prescribed for the offence if dealt with under this section.
 - (2) A notice under Subsection (1) may be served -
 - (a) personally; or
 - (b) by post; or
 - (c) by electronic means; or
 - (d) by leaving it on or in the premises of the person.
- (3) It is sufficient for the notice to be addressed in a letter format, containing the charge and the facts on which an offence has been committed and the appropriate fine.
- (4) A person alleged to have committed an offence to which Subsection (1) applies has the right to decline to be dealt with under this section.
- (5) For the purposes of Subsection (3), a person who fails to pay, within the time specified in the notice or such further time as is allowed in any particular case, the penalty to which a notice under Subsection (1) relates shall be deemed to have declined to be dealt with under this section.
- (6) Where the amount of the prescribed penalty for an alleged offence is paid in accordance with this section, no person is liable to any further proceedings for the offence.
- (7) Payment, in accordance with this section, of a penalty in respect of an alleged offence -
 - (a) shall not be regarded as an admission of liability for the purposes of this Regulation; and
- (b) does not affect or prejudice, any criminal proceedings, other than proceedings for the alleged offence or any civil claim, action or proceeding arising out of the same occurrence.
- (8) A penalty prescribed for the purposes of this section for a prescribed offence shall not exceed the maximum amount of penalty that could be imposed for the offence by a court.
- (9) Subject to Subsection (5) and (6), this section is supplementary to, and not in derogation of, any other provision of the Act, this Regulation or any other law in relation to proceedings that may be taken in respect of prescribed offences.

(10) Notwithstanding the Constitutional provisions relating to the imposition of a fine without a Court hearing, it is in the National interest for the benefit of public safety for an 'On The Spot' infringement fine to be imposed as a form of penalty according to the offender's desire.

243. POWERS OF ARREST.

- (1) Notwithstanding any other law but subject to the provisions of the *Arrest Act* (Chapter 339), this section applies to and in relation to an arrest for an offence made by or under this Regulation.
- (2) A policeman, an authorised office or agent of the Authority may, without warrant, arrest a person whom they believe on reasonable grounds:
 - (a) is committing; or
- (b) has committed an offence, under this Regulation.
- (3) For the purposes of this section a "policeman" means a member of the Police Force and includes Reserve Constabulary.
